Schedule A Itemized Deduction None

Using the Standard Deduction

Oregon workers/residents: The standard deduction for Single \$2745; Married \$5495; HOH \$4420. You may itemize everything except Oregon taxes paid if they are more than the Standard Deduction

The Federal Standard Deduction is Single/MFS \$11,600; Married Filing Jointly \$29,200; HOH - \$21,900. Generally, you will not itemize if the following does not exceed your standard deduction.

Itemized Deduction (continued)

- Large Medical Expenses:** No deduction is allowed for amounts that are less than 7.5% of your income. This includes:
 - Medical Insurance and Medicare Insurance premiums paid (*Not if it is thru employer when a 125 plan is in place*)
 - Long Term Health Insurance
 - Doctors, Dentist, Prescriptions, Vision and other medical provider expense.
 - Medical Transportation and Miles Driven (\$0.21)
 - Other Medical Expenses

- State and Local **Income Taxes** Paid
- Extra Sales **Tax** paid on Home Improvements & Automobiles (please bring proof)
